## REGULATIONS FOR THE BRIAN PERRY CHARITABLE TRUST BUSINESS MANAGEMENT SCHOLARSHIP

### REGULATIONS

---

1. The Scholarship shall be awarded each year by the University of Waikato Scholarships Committee, on the recommendation of the Selection Panel. The Selection Panel will consist of a representative of the Brian Perry Charitable Trust, a representative of the University of Waikato Scholarships Committee (or nominee), and the Executive Director Academic of the Waikato Management School (or nominee).
2. The Brian Perry Charitable Trust Business Management Scholarship is open to applicants who intend to enrol / have enrolled in the first year of a bachelor's degree in the Waikato Management School.
3. The Selection Committee may, at its discretion, require an applicant to undertake an interview.
4. The Scholarship will have a value of \$2,500. It is expected that a considerable amount of this sum will be used to defray course related costs.
5. Up to two Scholarships will be awarded annually, and will be paid in a single lump sum payment.
6. Applicants for the Scholarship must be New Zealand citizens or permanent residents.
7. Applicants should be completing their secondary schooling in the year prior to the year of tenure. In exceptional cases, the Selection Panel may consider applications from students who were not enrolled in secondary school in the preceding year.
8. In selecting the successful applicant(s) for the Scholarship, the Selection Panel will give preference to applicants who have demonstrated a high level of academic ability in NCEA Level 3 or 4 (or equivalent). Consideration will also be given to leadership potential, involvement in team situations, sporting interests and activities, and community involvement. Financial need may also be taken into consideration.
9. Applications for the Scholarship must be received by the University of Waikato Scholarships Office on the prescribed form by 31 March in the intended year of tenure.
10. Applicants must also submit:
  - (a) a brief curriculum vitae, which addresses the criteria given in point 8 above
  - (b) an academic reference
  - (c) a character reference
  - (d) a copy of their NCEA Level 3 results notice.
11. The Scholarship may be held together with any bursary, prize or student allowance, unless the conditions of the other Award preclude this.
12. Successful applicants will be advised of the offer of a scholarship in writing and must return their acceptance form by the prescribed date.

13. If any candidate declines a Scholarship, or does not take it up, the Selection Panel may offer the Scholarship to another applicant.
14. A Scholarship should normally be taken up in the year for which it is offered, and will have a maximum tenure of one year.
15. In applying for a Brian Perry Charitable Trust Business Management Scholarship, each applicant agrees that the University may approach the Principal of his or her secondary school to seek verification of details set out in the applicant's application.
16. Successful applicants will be required to attend a Scholarship Event where they will update Trustees and fellow recipients on their achievements. Recipients are also encouraged to send updates on their achievements to the Brian Perry Charitable Trust through the University of Waikato Scholarships Office.
