SIMPSON GRIERSON LAW SCHOLARSHIP UNIVERSITY OF WAIKATO

Simpson Grierson established this scholarship in 2003 to assist students studying for the LLB to complete their studies and gain work experience.

1. The scholarship shall be known as the Simpson Grierson Law Scholarship.
2. One scholarship shall be awarded annually, each with tenure of one year.
3. Applicants must be New Zealand citizens or permanent residents of New Zealand who, during the year following application, will be enrolled full time for their penultimate year of LLB study at the University of Waikato (in either a single or double degree programme).
4. The scholarship shall be awarded by the University of Waikato Scholarships Committee upon the recommendation of a selection committee comprising
 - a) a representative of the Scholarships Committee;
 - b) the Dean of the Faculty of Law (or nominee); and
 - c) two representatives of Simpson Grierson.
5. The scholarship shall be awarded following interviews with students short-listed by the selection committee. Interviews will take place in September or October each year.
6. In recommending the awards, the selection committee shall take into account:
 - a) academic achievement; and
 - b) professional skills; and
 - c) character, leadership potential, and social skills; and
 - d) the candidate's suitability as a future Simpson Grierson employee.
7. Should there be no candidate of sufficient merit in any year no award shall be made.
8. The scholarship will be paid in a single lump sum at the beginning of the first semester, following confirmation of the scholar's enrolment.
9. The Scholar will be employed by Simpson Grierson as a Summer Clerk in Auckland or Wellington at the end of the year of tenure. Acceptance of a Summer Clerk position is a compulsory component of the scholarship and should a scholar fail to complete the summer internship they will be required to repay the scholarship. The Scholar will also have the possibility of obtaining full-time graduate employment with Simpson Grierson.
10. A Simpson Grierson mentor will be allocated to the scholar to provide them advice and guidance on their studies and career.
11. The University of Waikato Scholarships Committee may terminate or suspend the scholarship, if it receives an unsatisfactory report on the progress of a scholar from the Dean of Law.
12. The University of Waikato may amend or vary these Regulations, in consultation with Simpson Grierson, provided there is no departure from the main purpose of the scholarship.
13. Provision of the Scholarship will be reviewed annually by Simpson Grierson. Provision may be terminated by Simpson Grierson giving at least two months notice prior to the application closing date.
14. Applications for the scholarship are to be made on the appropriate form obtainable from the Scholarships Office, Faculty of Law, or Simpson Grierson website and forwarded to the Scholarships Advisor, University of Waikato, not later than 1 September in the year prior to tenure.

NOTE: The value of the scholarship is \$3,000.
