OVERVIEW OF THE 3MT COMPETITION

The Three Minute Thesis (3MT®) is an academic competition developed by The University of Queensland (UQ), Australia for research students.

The 3MT competition is for higher degree research candidates enrolled in the PhD, EdD, SJD or DHSc programmes.

The competition challenges candidates to present a compelling oration on their thesis and its significance in just three minutes in language appropriate to an intelligent but non-specialist audience. This presentation should address the following questions:

- What are you researching?
- · Why are you researching this topic?
- What are the values or outcomes of your research?

The purpose of the 3MT Doctoral Competition is to encourage students to develop and demonstrate their ability to communicate about the research they are undertaking and the wider social, community, political, scientific and/or economic value of that research.

It also provides an opportunity to disseminate the research findings to audiences who might otherwise not even become aware of projects being undertaken. 3MT is not an exercise in trivialising or 'dumbing-down' research but forces students to consolidate their ideas and crystallise their research discoveries.

The finalists of the 3MT Doctoral Heats will go on to present at the University of Waikato 3MT Doctoral Final on **Tuesday 8 August 2023** from 6.30pm in the Concert Chamber of the Gallagher Academy of Performing Arts. Hamilton.

The winner of the 3MT Doctoral Final will represent the University of Waikato at the 2023 Virtual Asia-Pacific 3MT Competition on **Monday 25 September 2023** for the Asia-Pacific 3MT Semi-Finals and potentially, **Wednesday 18 October 2023** for the Asia-Pacific 3MT Finals.

MC AND JUDGES



MC: Professor Karin Bryan

Professor Karin R Bryan is the Dean of Te Mata Kairangi, School of Graduate Research at the University of Waikato. Previously, she was Director of the Environmental Research Institute at the University of Waikato and Assistant Dean in the School of Science. Karin Bryan is a physical oceanographer, specialising in coastal dynamics and sediment transport. Since arriving at the University in 2002, she has completed a wide range of research projects, covering mangroves, wave climatology, rip currents, estuarine tidal dynamics and sediment stability. Karin has graduated 23 PhD and 29 MSc students and written 140+ peer-reviewed papers to support this work. Her latest work is on the TAIAO Environmental Data Platform with the Artificial Intelligence Institute at Waikato led by Prof Albert Bifet, where she is working on combining dynamical modelling and remote sensing to optimize predictability in the coastal environment.

JUDGE 1: Associate Professor Te Taka Keegan

Associate Professor Te Taka Keegan is the Associate Dean Māori, within Rorohiko Me Ngā Pūtaiao Pāngarau School of Computing & Mathematical Sciences.

Te Taka's general research interests include traditional navigation, Māori language technologies, indigenous language interfaces, multilingual usability, and is currently focusing on the use of Te Reo Māori in a technological environment.



JUDGE 2: Dr Alison Campbell

Dr Campbell served the University of Waikato for 23 years in her capacity as Senior Tutor, then Lecturer and then Senior Lecturer, as Associate Dean (Teaching & Learning) for Science Engineering, as a University Council member and as a Faculty representative on many of the University's committees.

In the wider community, she has been an advocate for science, encouraging those outside academia to engage in scientific investigation and using science to explain topical health issues.

Dr Campbell is well known for promoting science to community groups and schools. She established Café Scientifique in Hamilton and reaches a wide audience with the Sciblogs-syndicated blog.



JUDGE 3: Dr Rangihurihia McDonald

Dr. Rangihurihia McDonald (Ngāti Maniapoto) is the Pou Ārahi at the University of Waikato Library. Her current work is focused on Māori student and staff equity, biculturalism, Te Tiriti o Waitangi and antiracism within the Library. Dr. McDonald is a kaupapa Māori researcher who has recently defended her PhD thesis which focussed on mātauranga whakatere waka (traditional Pacific voyaging knowledge) and climate change.

Outside of work Rangihurihia enjoys the gym, live music, card games, road trips, walks and relaxing at home in Waitomo.

GENERAL INFORMATION

ELIGIBILITY

All currently enrolled University of Waikato candidates in a PhD, EdD, DMA, SJD or DHSc programme who have reached Confirmed Enrolment (Part 2 EdD, SJD, DHSc), as well as those candidates whose thesis is under examination are eligible to enter. Candidate's must be currently enrolled or be under examination during the heats and the Asia-Pacific 3MT final competition and are not eligible to enter if they are on suspension. Graduates are not eligible to apply for this event.

RULES

- Presentations are limited to 3 minutes and competitors exceeding 3 minutes are disqualified.
- Presentations are to commence from stage.
- Presentations are considered to have commenced when a presenter starts their presentation through speech (timing does not include the 3MT title slide and commences from when the competitor starts speaking).
- A single static slide is permitted in the presentation (no slide transitions, animations or 'movement' of any description). The slide is to be presented from the beginning of the oration.

- The 3 minute presentation must be continuous.
- No additional props (e.g. costumes, musical instruments, laboratory equipment and animated backgrounds) are permitted.
- Presentations are to be spoken word (e.g. no poems, raps or songs).
- No additional electronic media (e.g. sound and video files) are permitted.
- The decision of the adjudicating panel is final.

JUDGING CRITERIA

Each competitor will be assessed on the judging criteria listed below. Each criterion is equally weighted.

1. Comprehension and Content:

- Presentation provided clear background and significance to the research question
- Presentation provided clear positionality of the presenter to the research and research approach
- Presentation clearly described the research strategy/design and the results/ findings of the research
- Presentation clearly described the conclusions, outcomes and impact of the research

2. Engagement and Communication:

- The oration was delivered clearly, and the language was appropriate for a nonspecialist audience
- The PowerPoint slide was well-defined and enhanced the presentation
- The presenter conveyed enthusiasm for their research and captured and maintained the audience's attention.

OTHER THINGS TO CONSIDER

Your presentation should consider any Intellectual Property (IP) issues. If content is embargoed or sensitive, your presentation will need to be structured to avoid compromising this.

The University of Waikato reserves the right to withdraw any candidate from this competition if they do not meet the eligibility criteria or are found to have breached University of Waikato protocol, either by plagiarising part or all of their presentation or acting in a manner that does not promote fair competition.

A. The overall winner will receive a \$500 cash prize and the runner up will receive a \$250 cash prize.

Q. Can I bring props along?

A. No.

O. Can I use sound or video?

A. No.

Q. Can I use animations in my PowerPoint slide?

A No Your slide must be static

Q. Is the 3MT Masters Competition open to the public?

A. Yes, it is open to the public and competitors. We encourage you to bring support, as well as to watch fellow competitors.

O. Can I present by video conference?

A. No, all competitors must present in person.

Q. What do you mean by one slide?

Q. What happens if my presentation goes over the allocated three minutes?

A. You will be disqualified.

O. Is there an official Time-Keeper?

A. Yes, you will be timed using a timer on an iPad (or equivalent), and this will be visible to you at all times while you present. When you have 30 seconds remaining, the Time-Keeper will raise a orange baton, so you have another prompt that it is time to wrap up your presentation.

Q. If I was a 3MT contestant last year, can I enter again this year?

A. The overall winners and runners-up from previous competitions will not be permitted to compete again this year. All other contestants can enter provided they meet the eligibility criteria.

Participants must be enrolled in their University of Waikato Doctorate or be under examination for the duration of the competition (Thursday 6 July 2023 to Wednesday 18 October 2023). Graduates and candidates on suspension are not eligible. 3. Entries must be received no later than 4.00pm. Friday 16 June 2023, 4, All entrants must be available to attend the University of Waikato 3MT Doctoral Final on Tuesday 8 August 2023 as well as the 2023 Virtual Asia Pacific 3MT Doctoral Competition. The Virtual Asia-Pacific 3MT Semi-Finals online showcase will be on Monday 25 September 2023 and the Virtual Asia-pacific 3MT Finals on Wednesday 18 October 2023. If the winner is unavailable to compete in the Virtual Asia-pacific 3MT competitions, the runner-up may be invited to represent the University instead, 5, All presentations for the University of Waikato 3MT Doctoral Heats and the University of Waikato 3MT Doctoral Finals must be delivered in-person in front of the judging panel. Presentations cannot be pre-recorded or delivered via video-conference. 6. You must agree to abide by the guidelines for using one static PowerPoint slide to assist your presentation. No transitions or other props will be allowed. 7. You must agree with the University of Waikato Marketing, Publicity Consent and Release Declaration (below). 8.
