Noted in discussion

- 1. That thanks were expressed to everyone involved in the development of the Round Two 2022 Academic Developments. These had all been approved by CUAP and we were now waiting for the Tertiary Education Commission (TEC) to make the two new Māori immersion programmes live, so that enrolments for these programmes could commence.
- 2. That in 2023 the Graduating Year Review (GYR) process would revert back to the pre-Covid process and, therefore, GYRs would need to be submitted to CUAP for approval again. Our GYR template was currently being reviewed.

22.84 REPORT OF THE RESEARCH COMMITTEE

Noted in discussion

1. That Te Ara Paerangi – Future Pathways white paper had now been released. Staff were encouraged to read the white paper as it was a chance to be involved in a significant transformation of research, science and innovation in New Zealand. In addition, it provided an excellent opportunity to creatively redesign how we do research and ensure that Te Tiriti was embedded in what we do. That the timeframes for this reform process extended over several election cycles. Some consultation had commenced, but there would be ongoing consultation opportunities throughout the process.

2. That the Deputy Vice-Chancellor Research had held a workshop with Council's People and Culture Committee on the role of research and researchers in the University.

22.85 REPORT OF THE PACIFIC STRATEGIC COMMITTEE

ALPSS Masters (22/429k)

1. That the Prescriptions in this proposal should be revised to include only reference to allowing 60 points to be taken from outside the field of the degree. Any prescription changes relating to the Category C proposal 22/429j, which was withdrawn from this round, should be removed.

Graduate Diploma in Teaching/Postgraduate Diploma in Teaching (22/429q)

2. That the Date of Implementation should be amended to 31 December 2022.

Resolved

- 1. To approve the 19 Category C proposals, as set out in documents 22/429a-i and 22/429k-t, subject to amendments to 22/429k and 22/429q as noted in discussion.
- 2. To approve the Disciplinary Foundations, Cultural Perspectives and Work-Integrated Learning regulations, as set out in documents 22/435a-f.

22.89 ENGLISH LANGUAGE ENTRY REQUIREMENTS

Reported

That the proposal to amend the English language entry requirements had been recommended by the Divisional Boards in October 2022 and Education Committee in November 2022. It had been amended following feedback from the Education Committee.

Noted in discussion

That this proposal sought to extend the acceptance of online English language tests and to recalibrate these tests, where required.

Resolved

To approve the proposal to amend the English language entry requirements, as set out in document 22/420.

22.90 ENGLISH LANGUAGE EQUIVALENCIES COMMITTEE

Reported

That the proposal to establish a committee to approve changes to the University's English Language Equivalencies had been recommended by the Divisional Boards in October 2022 and Education Committee in November 2022. It had been amended following feedback from the Education Committee.

Noted in discussion

- That the terms of reference and constitution of the English Language Equivalencies committee should be amended to include the Director, International Office as an ex-officio member. In addition, it was agreed that the Pacific Strategic Committee (PSC) should have a representative on the committee and should receive the reports of the committee.
- 2. That differences between the English language entry requirements of universities and those set by immigration services was a challenge being seen internationally.

Resolved

The delegation of authority to approve changes to English language admission equivalencies to the English Language Equivalencies Committee, as set out in document 22/421.

22.91 AMENDMENT TO THE RESEARCH COMMITTEE CONSTITUTION

That the amendment to the Research Committee constitution, to include the Director of Innovation and Impact, was discussed at the meeting of the Research Committee on 2 November 2022.

- 1. That the Research Committee currently had a Pacific representative as a co-opted member, however, it would be good to formalise Pacific representation on the committee. It was agreed that the constitution should be amended to include a representative from PSC as an appointed member.
- 2. That wording in clause 7 of the constitution should be amended from Board to Faculty.

Resolved

To approve the amendment of the Research Committee constitution to include:

- 1. The Director of Innovation and Impact as an ex officio member, as set out in document 22/509.
- 2. A member of the Pacific Strategic Committee as an appointed member.

22.92 STUDY LEAVE REPORT

- 2. That the study leave policy had been amended to provide more flexibility, particularly in relation to staff being able to take shorter periods of leave. In addition, travel allowances had been increased and approval for travel related to study leave was now automatic.
- 3. There was an uneven distribution of study leave being taken across the divisions, and all staff should be encouraged to use their study leave entitlements.
