ACCESSIBLE PARKING POLICY

AT THE UNIVERSITY OF WAIKATO

Accessible parking spaces (outlined in yellow and displaying the wheelchair symbol) are provided for use by people with mobility-related impairments free of charge. These parking spaces may be used only by holders of Operation Mobility permits issued by the CCS Disability Action or Temporary Mobility Parking Permits issued by the University's Disability Support Service (located adjacent Gate 1 carpark next to the University Medical Centre).

Accessible parks are provided for the use of people with physical mobility-related impairments and are clearly marked as such. They are exclusively reserved for holders of Operation Mobility permits issued by CCS and **temporary permits** issued by the Disability Support Service.

If you require parking for a period longer than 3 months you must apply for and display a CCS Mobility Parking permit. Temporary Mobility permits will only be issued to staff/students requiring access to mobility parking for a period less than 3 months.

University Parking Attendants vigorously police these parks to ensure only those DISPLAYING permits park there. It is therefore essential that all legitimate permit holders clearly display theirs on windscreens or dashboards etc. You must display your permit or you run the risk of being clamped. Holders of Operation Mobility Permits and temporary permits are required to observe the University's Parking and Traffic Regulations i.e. no parking on yellow lines, service areas, fire hydrants or on the grass and to adhere to speed limits.

What if all the accessible parks are full?

If, **and only if**, all accessible parks are full permit holders can park in Visitor parking. A small number of limited-time parking spaces, including accessible parking spaces for people with mobility-related impairments, are provided on campus free of charge for visitors; these parking spaces must not be used by staff or students. These options are only as a last resort and can only be used if the nearby accessible parks are full. If you are seen parking in one of these parks and there are nearby accessible parks that are empty you will be clamped. We need to emphasise this because if access to these alternative parks is abused you may risk either having the vigorous attendance of mobility parks being scaled down, or the loss of access to these areas.

Paid parking applies to all other parking areas on campus **Monday to Friday, 8.30am to 4.30pm**, (excluding public holidays). Outside these times parking is free, however you cannot park in a Numbered/Named (reserved) park at ANY TIME - these are reserved for the permit-holder at all times.
