Performance Based Research Fund (PBRF)

- 1. That a report for faculties would be complied on the first draft of PBRF portfolios. Staff were encouraged to complete their first draft before the Christmas break.
- 2. That staff were reminded that editorial support was available, however that was somewhat dependant on how quickly work was received as there needed to be sufficient work available to make the support viable.

### Marsden Fund

- 3. That the emphasis for the Marsden Support Fund was on the provision of editorial support, and to support staff to build the capacity to write a Marsden proposal.
- 4. That it was raised that the number of proposals submitted by professors had been disappointing with only around a quarter of all University professors involved in Marsden bids. It was noted that the University was as successful as other universities with regard to Marsden grants, but the number of proposals needed to increase.
- 5. That the Associate Dean Research would encourage and shoulder tap staff with the potential to apply for Marsden. More work would be undertaken to support mid-career staff.

- 1. That it was reported that three work streams were associated with Academic Integrity:
  - a. a statement to appear everywhere
  - b. the redevelopment of Academic Integrity modules. The first iteration, developed by CeTTl had been reviewed and a revised module would be available in 2018.
  - c. the development of resources for staff and students
- 2. That consultation had been undertaken by Pro Vice-Chancellor Teaching and Learning and other members of the Academic Integrity Working Group within faculties. The te reo statement had been developed in consultation with Associate Professor Tom Roa and there had been a robust process around its development.
- 3. That much of the feedback received was in relation to the definition of plagiarism included in the paper outline. The paper outline policy would also be reviewed and revised as part of this workstream and it was hoped a revised statement would be ready for A Semester 2018.
- 4. That the Academic Integrity Statement in the Paper Outline should include plagiarism, but could also incorporate other elements such as ethical concerns, and it could be broadened to include intellectual property and intellectual theft. It was suggested that it may be useful to develop a broad general statement and a more specific statement focussed on plagiarism.
- 5. That it was suggested that the statement should be read in conjunction with the Student Code of Conduct.

#### Recommended

- 1. That the plagiarism statement to be included in the Paper Outline be developed by B Semester 2018.
- 2. That the Academic Integrity Statement be integrated with the Student Code of Conduct and return for consideration in 2018.

Approval of the revised Academic Integrity Statement, as set out in document 16/376, to be implemented in A Semester 2018.

# 17.97 DEED OF COOPERATION BETWEEN TOI OHOMAI, TE WHARE WANANGA O AWANUIARANGI AND THE UNIVERSITY OF WAIKATO

That a concern was raised that the amendment removed the Deans discretion with respect to committee appointments, as the member was appointed ex officio, by virtue of their position, (ie Associate Dean Academic) and could mean that the person responsible for curriculum development was not on the appropriate committee.
- 2. That the intention of the constitutional amendment to Academic Board, Education Committee and Curriculum Committee, was to enable the Dean to appoint staff who were engaged with the work and could best represent the Faculty. With respect to the Education Committee and Curriculum Committee, this should be the person responsible for curriculum development, which in some instances may not be a member of the academic staff. It was noted that where this was the case, curriculum would be developed with support of, and on behalf of academic staff.
- 3. That the amendment to the constitution of the Education Committee would align it with the constitution of the Research Committee.
- 4. That it was suggested that the co-option clause provided an opportunity for nonacademic staff to be appointed to a committee for particular purposes, and could be a preferable pathway to a constitutional amendment.

- 1. Approval of the amendment to the constitution of the Education Committee, as set out in Appendix 2 of document 17/473.
- 2. Approval of the amendments to the constitution of the Curriculum Committee, as set out in Appendix 3 of document 17/473.
