The meeting was opened with a karakia.

REGISTER OF INTERESTS

Council confirmed a register of its members' declared interests.

MINUTES OF THE MEETING HELD ON 28 FEBRUARY 2023 (PART 1)

Council confirmed the minutes of the Council meeting held on 28 February 2023 (Part 1).

REPORT OF THE VICE-CHANCELLOR (PART 1)

Council received a written report from the Vice-Chancellor.

Council received a further oral report from the Vice-Chancellor from which it was noted that the University would be holding its 2023 Open Days on 26/27 May (Hamilton) and 9 June (Tauranga).

Council noted that the University would proceed with some new staff recruitment and would be seeking to fill some positions that had been held as open vacancies for some time.

Council noted the University's success in significantly increasing its enrolments in Nursing in 2023.

UNIVERSITY OF WAIKATO 2022 ANNUAL REPORT

Council noted the advice of the Chief Operating Officer that Audit New Zealand had not yet completed its annual audit of the University of Waikato.

Council resolved that provided that Audit New Zealand did not require any material changes to be made to the Annual Report as drafted, to delegate authority to the chancellor to approve the 2022 University of Waikato Annual Report for public release.

Council resolved that should Audit New Zealand require material changes to be made to the Annual Report as drafted, an updated Annual Report, including a summary of changes made in response to Audit New Zealand's requirements, would be circulated to Council members for consideration and approval.

LEASE APPROVAL

Council resolved to delegate authority to Vice-Chancellor to enter into a 15-year operating lease with the Tauranga Energy Consumer Trust (TECT) for the properties at 127 and 143 Durham Street Tauranga...

CYCLE 6 ACADEMIC AUDIT

Council received the University's draft Cycle 6 Academic Audit Report.

Council noted that the site visit for the Cycle 6 Academic Audit would take place during the week commencing 4 September 2023.

DRAFT PACIFIC STRATEGY IMPLEMENTATION PLAN 2023-2025

Council received the draft Pacific Implementation Plan that would guide activities undertaken in 2023-2025 to deliver on the University Pacific Strategic Plan 2021-2025.

MICROSOFT 365 PROJECT

Council endorsed the Vice-Chancellor's decision to proceed with a project to replace the University's current Google Workspace Productivity software with the Microsoft Modern Workspace framework.

Council noted that the cost of the project would be offset by the one-off sale of the University's surplus IP addresses which had been approved by the Capital and Finance Committee and the Secretary for Education.

VICE-CHANCELLOR'S 2023 PERFORMANCE OBJECTIVES

Council received the Vice-Chancellor's 2023 performance objectives that had been negotiated and approved by the People and Culture Committee.
