# STUDENT ACCOMMODATION OPPORTUNITIES

Council received an update from the Chief Operating Officer with respect to the University's proposed student accommodation developments in Hamilton and Tauranga.

Council resolved to delegate authority to the Vice-Chancellor and Chief Operating Officer to enter into two formal agreements to lease, subject to specific conditions being met, future student accommodation developments in Tauranga.

Council resolved to approve the University proceeding with the development of a modular construction student accommodation development on its Hillcrest campus, and to approve the University directly funding this development, costed at \$16.5m, as a variation to its approved capital programme.

# **FUTURE DIRECTION FOR UNIVERSITIES**

Council received a summary of a cabinet paper from the Minister for Universities that set out a future direction for New Zealand universities including Government's response to the recommendations of the University Advisory Group.

Council also received the draft Tertiary Education Strategy, together with a review prepared by Tertiary Insight.

## REPORT OF THE STUDENT DISCIPLINE APPEALS COMMITTEE

Council received a report from the Student Discipline Appeals Committee.

### **VICE-CHANCELLOR'S 2025/2026 KPIS**

Council considered proposed key performance indicators and targets for the Vice-Chancellor for the period 2025/2026.

Council noted that the proposed indicators reflected those already agreed by Council with respect to reporting against the University Strategy.

Council resolved to request that the People and Culture Committee work with the Vice-Chancellor to develop a suite of four to five indicators for the period that focussed on the Vice-Chancellor's personal goals and intended outputs.

#### **AUDIT ARRANGEMENTS: UNIVERSITY OF WAIKATO**

Council noted that the University had received advice from the Office of the Auditor General with respect to the appointment of the University's auditor for its annual year-end audit.
