- all teachers are more confident and competent in NCEA assessment resource task design that meet the needs and interests of their learners
- improved teacher assessment practice and skills from Y9 13
- the development of a graduate profile and learner profile tool
- career pathways that met every students needs and interests
- students leaving school with a minimum of NCEA Level 2
