

Braemar Charitable Trust Scholarship in Nursing – 2026

The Braemar Charitable Trust Scholarship in Nursing was established in 2021 through the generous donation of the [Braemar Charitable Trust](#). The Trust aims to improve health outcomes in our communities and to advance health equity and access. In particular, the Trust strives to help those who face challenges accessing health services and, as a result, suffer poorer health and health outcomes. The Trust has five key pillars to achieve this goal, including ownership of Braemar Hospital; contributing to research that advances medical knowledge; growing the medical workforce and their knowledge and skills; promoting collaboration for better health outcomes and facilitating community surgery and health interventions for eligible patients.



Up to two \$10,000 Scholarships will be awarded each year (2024-2026) to students in their second year of the Bachelor of Nursing.

1. Purpose

- 1.1. The Scholarship provides financial support for promising second year Bachelor of Nursing students from populations, communities and/or regions typically under-represented in nursing who might not otherwise be able to access education. It is specifically intended for those who reside in the Waikato Te Whatu Ora region and plan to pursue a career in nursing upon graduation, in the wider Waikato Te Whatu Ora region.

2. Eligibility and Selection Criteria

- 2.1. **To be eligible, applicants must** meet all following criteria:
 - 2.1.1. be enrolled full-time (i.e., 120-points) in the second year of their Bachelor of Nursing at the University of Waikato in the year of tenure.
 - 2.1.2. be from a population, community and/or region typically under-represented in nursing and which experiences barriers to attending University.
 - 2.1.3. have been enrolled full-time (i.e., 120-points) and achieved at least a B+ average in their first year of study at the University of Waikato.
 - 2.1.4. reside in the Waikato Te Whatu Ora region and intend to work in healthcare in the wider Waikato Te Whatu Ora region upon graduation.
 - 2.1.5. be eligible for domestic fees status (i.e., be a NZ Citizen, NZ Permanent Resident, NZ Resident Class Visa holder, or Australian Citizen/Permanent Resident domiciled in NZ).
- 2.2. **Selection will be based on** all the following criteria:
 - 2.2.1 academic merit.
 - 2.2.2 the likelihood of the applicant using their study to contribute to the NZ health sector, particularly in the wider Waikato Te Whatu Ora region.
 - 2.2.3 alignment of the applicant to the purpose of the scholarship.
- 2.3. Financial hardship and extraordinary personal circumstances may also be taken into consideration.
- 2.4. **To maintain eligibility recipients must**, in the year of tenure:
 - 2.4.1 remain enrolled full-time (120-points) in a Bachelor of Nursing.

2.4.2 pass all courses in A Trimester.

3. Value, Tenure and Awarding

- 3.1. The Scholarship has a value of **\$10,000** and will be paid as follows:
 - 3.1.1 **\$5,000** will be paid directly to the recipient as soon as practicable after acceptance of the Scholarship, or after the withdrawal date of A Trimester (whichever is latest).
 - 3.1.2 **\$5,000** will be paid directly to the recipient after the withdrawal date of B Trimester and is conditional on the student passing all courses in A Trimester in the year of tenure.
- 3.2. The Scholarship has a tenure of one year.
- 3.3. The successful applicants will be advised of the offer of a Scholarship via their MyWaikato portal and must accept the offer by the prescribed date or the offer will lapse.
- 3.4. In accepting the Scholarship, the recipient will be deemed to have:
 - 3.4.1. read, understood, and accepted the conditions of the Scholarship, and the [Scholarships Policy](#).
 - 3.4.2. agreed to participate in any publicity concerning the Scholarship arranged by the University of Waikato and/or Donor.
 - 3.4.3. agreed to be contacted directly by staff of the Braemar Charitable Trust.

4. Application

- 4.1. The closing date for online applications is **15 March annually**.
- 4.2. As part of the online application process, each applicant must provide information on the following within the online application form:
 - 4.2.1. Why completing their degree is important to them and their future ambitions.
 - 4.2.2. The applicant's intention to work in healthcare in the wider Waikato Te Whatu Ora region upon graduation.
 - 4.2.3. That the applicant is from a population, community or region that is typically under-represented in nursing.
 - 4.2.4. Any financial circumstances that are relevant.
 - 4.2.5. Any other information that may be of relevance to the Selection Panel.
- 4.3. As part of the application process, applicants must also request the submission of:
 - 4.3.1. one confidential professional reference. This could be from their current workplace or from a placement they have completed.
 - 4.3.2. one clinical reference from a nurse, educated preceptor or a clinical academic. It is important for the applicant to follow up with their referee to ensure the reference is submitted by the deadline (5 days following the closing date).

5. Selection Panel

- 5.1. The Selection Panel will comprise the Scholarships Committee representative from the Division of Health (in the Chair), an academic staff member in Nursing (appointed by the Head of School of Nursing and Midwifery), and up to two representatives appointed by the Braemar Charitable Trust.
- 5.2. The Selection Panel may refrain from making a decision if it finds no candidate of sufficient merit.

- 5.3. The Selection Panel's decisions are final and no further correspondence will be entered into following the selection meeting.

6. Other Conditions

- 6.1. The Scholarship may be held in conjunction with any other Scholarship, Award or Prize, unless the conditions of the other award preclude this.
- 6.2. Recipients should seek independent financial advice about any tax implications of their scholarship.
- 6.3. Should a recipient withdraw from any papers, without adding sufficient papers to maintain an overall enrolment in a minimum of 120-points for the academic year, the University may ask for the Scholarship to be repaid.
- 6.4. Through the School of Graduate Research, the University monitors recipients' performance and reserves the right to impose further conditions where a recipient's performance is unsatisfactory.
- 6.5. The Scholarships Committee may terminate this Scholarship at any time, and recoup any funds disbursed, if the holder withdraws from the University of Waikato, brings the Scholarship, University or Donor into disrepute¹, or is otherwise not complying with the regulations governing the Scholarship and/or the University of Waikato. The holder of a Scholarship will have the right to appeal to the Scholarships Executive against any decision to terminate the award.
- 6.6. The Scholarships Committee may, from time to time, vary these regulations.
